

Construction Career Up System Engineer Information – Apply for Registration

Construction Career Up System – Terms of Use Agreement

※Required for all Registrants

To apply for the use of the Construction Career Up System, it is required that you agree to the Terms of Use of the System. In addition, the Foundation defines the policy for the handling of personal information of the users registered in the System as follows. Personal information shall be handled legally and appropriately, in compliance with the Act on the Protection of Personal Information and other related laws, as well as regulations defined by the Foundation.

Construction Career Up System – Privacy Policy

■ Handling of personal information in the Construction Career Up System (Appendix)

1. Purpose of Use

(1) For a proper assessment of an engineer with regard to his/her skills and experience and to improve working conditions, the engineer, his/her Business Operator and the main contractor shall register, store, and update the "Engineer's basic information" (referred to as personal information listed in Table 1 of the Appendix; the same shall apply hereinafter) and "Engineer's work history information" (referred to as personal information listed in Table 2 of the Appendix; the same shall apply hereinafter) on the System as follows:

- (1)-1. The engineer (or his/her business operator, business association, etc.) shall register and update his/her basic information on the System.
- (1)-2. The engineer's Business Operator, main contractor, the engineer himself/herself shall register, store, and update his/her work history information on the System.
- (1)-3. The engineer's Business Operator, main contractor shall register and update the "Business Operator's information" (referred to as personal information listed in Table 3 of the Appendix; the same shall apply hereinafter), "Site/Contract information" (referred to as personal information listed in Appendix Table 4; the same shall apply hereinafter) which constitutes the engineer's work history information on the System.
- (1)-4. The engineer's work history information and basic information, the business operator's information, and the site/contract information on the System shall be registered, stored, and updated by linking (sharing) to private and secure entry/exit management systems and safety management systems certified by the Foundation.

(2) For registered users to understand and properly assess the capabilities of excellent engineers and their Business Operators using the engineer's basic information, the engineer's work history information, his/her Business Operator's information and the site/contract information are registered and stored on the System as described in Section (1). To improve the engineer's employment stability and working conditions, as well as the mechanism to assess the technical capabilities of the engineer and construction capabilities of the Business Operator:

- (2)-1. The engineer's basic information, his/her work history information, Business Operator's information, and the site/contract information shall be shared among the Registered Users. However, for companies other than the engineer's business operator, this does not apply to the engineer's basic information and work history information that the engineer himself/herself or his/her business operator does not agree to share.
- (2)-2. Regarding the engineer's basic information and work history information, only items of which consent from the engineer himself/herself and his/her Business Operator has been obtained shall be provided within necessary scope to an external user for the assessment of the engineer's technical capabilities and the Business Operator's construction capabilities.
- (3) For the main contractor and subcontractor to employ the engineer's basic information, his/her work history information, the Business Operator's information and the site/contract information registered and stored as described in (1) to ensure health and safety at the site at which engineers enter and work, to ensure social insurance participation, to ensure appropriate issue of mutual aid certificate of the construction industry retirement allowance mutual aid system for proper work management and implementation at site and for improvement of construction quality.
 - (3)-1. The engineer's basic information, his/her work history information, the Business Operator's information, and the site/contract information are, within the necessary scope, shared with the main contractor, the main subcontractor of the site, and the engineer's Business Operator.
 - (3)-2. The engineer's basic information, his/her work history information, the Business Operator's information, and the site/contract information will be linked (shared) to private and secure entry/exit management systems, safety management systems certified by the Foundation and the System.
- (4) To ensure the proper and smooth operation of the System, such as registration process, communication, the engineer's identity verification, the Business Operator's identity verification, etc.
- (5) For the development of the System, for public relations activities to related parties, and necessary investigations for the enhancement of the System.
- (6) For investigation and analysis of problems in the construction industry.

2. Sharing of personal information

(1) Sharing purpose:

Similar to the Purpose of Use, Sections (1) ~ (3).

(2) Items of personal information to be shared:

- ① Engineer's basic information
- ② Engineer's work history information
- ③ Business operator's information
- ④ Site/Contract information

However, regarding Section (2)-1 in the Purpose of Use, for companies other than the engineer's business operator, information sharing does not apply to the engineer's basic information and work history information that the engineer himself/herself or his/her Business Operator does not agree to.

(3) Scope of Sharing:

- ① Users or operators of private entry/exit management systems, safety management systems (those certified by the Foundation as satisfying the requirements to be linked with the System) that hold or intend to hold all or part of the basic information and work history information of the engineer who engages in or will be engaged in the corresponding construction work (Purpose of Use Sections (1)-4 and (3)-2).
- ② The Registered Users of the System (Purpose of Use Section (2)-1 and (3)-1).

However, for Section (3)-1, it is limited to the engineer's Business Operator, the main contractor and the main subcontractor.

(4) The person responsible for managing personal information:

- ① The General Manager of the Construction Career Up System
- ② Private systems certified by the Foundation

■ Construction Career Up System – Terms of Use
Suspension of use

1. If the Registered User exercises any of the following acts, the Foundation shall temporarily suspend the use of this service without any prior notice or caution, disable the account or cancel the Service Use Agreement with the Registered User.

- (1) Violation of any provision of this Agreement.
- (2) A registered corporate user that suspends payment of the service fee or is unable to pay, or has filed a petition for commencement of bankruptcy proceedings, civil rehabilitation proceedings, company reorganization proceedings, special liquidation, or other similar proceedings.
- (3) The System has not been used for 12 months or more.
- (4) No response for 14 days or more to inquiries or other requests from the Foundation.
- (5) Any act set forth in Paragraph 4, Article 5.
- (6) Other cases, such as registration, use of the service, continuance of the Service Use Agreement deemed inappropriate by the Foundation to ensure proper system operation.

2. If any of the items listed in the preceding paragraph applies, the Registered User shall forfeit the benefit of time regarding the financial obligations towards the Foundation and shall immediately pay all outstanding debts to the Foundation.

3. The Foundation shall not be liable for any damages incurred by the Registered User due to actions taken by the Foundation according to the provisions of this Article.
